TO ALL CONCERNED PERSONS AND AGENCIES:

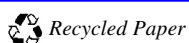
Enclosed is the Notice of Public Hearing concerning the tentative NPDES Permit renewal and Cease and Desist Order (CDO) for the Donner Summit PUD Wastewater Treatment Plant. Also enclosed is the tentative NPDES Permit Renewal package which includes the following items:

- (1) The tentative NPDES Permit,
- (2) The tentative CDO, and
- (3) Tentative NPDES Permit Options addressing dilution.

To be given full consideration, any comments or recommendations you may have regarding the enclosed tentative NPDES Permit Renewal package must be submitted in writing to the Regional Water Quality Control Board (Regional Water Board) office by 5:00 p.m. on **6 March 2009**. Written material submitted after 5:00 p.m. on **6 March 2009** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

Regulations require that the Discharger (1) publish the Notice of Public Hearing in a local newspaper for one day, and (2) post one copy of the Notice at the nearest city hall or county courthouse, at the post office nearest to the Facility (if allowed), and at the public entrance to the treatment facility. The required publishing and posting must take place no later than **4 February 2009**.
