NOTICE OF APPLICABILITY

WAIVER OF REPORTS OF WASTE DISCHARGE AND WASTE DISCHARGE REQUIREMENTS FOR SPECIFIC TYPES OF DISCHARGE WITHIN THE CENTRAL VALLEY REGION, DONNER SUMMIT PUBLIC UTILITY DISTRICT, RECYCLED WATER FOR USE AS ROAD DUST CONTROL, NEVADA COUNTY

On 4 April 2019, the Donner Summit Public Utility District (hereafter "Discharger") submitted a Report of Waste Discharge (RWD) to obtain coverage under the *Waiver of Reports of Waste Discharge and Waste Discharge Requirements for Specific Types of Discharge within the Central Valley Region, Order R5-2018-0085* (the Waiver). The submittal contains all the information required to evaluate the applicability of the Waiver; therefore, the RWD is considered complete and the discharge meets the conditions of the Waiver. The discharge is hereby covered under the Waiver Order R5-2018-0085-0004. Please include this number on all correspondence related to this discharge.

PROJECT LOCATION AND DESCRIPTION

The Discharger is proposing to use treated tertiary effluent from the Donner Summit Public Utility District Wastewater Treatment Plant (WWTP) for road dust control. Discharge from WWTP is permitted under Order No. R5-2015-0068 (NPDES No. CA0081621), adopted on 4 June 2015, which allows surface water discharges, land application, and use of the treated effluent for snow making.

The Discharger is planning on improving Donner Pass Road, beginning at Interstate 80 and Donner Pass Road (Exit 174) and ending approximately 7 miles east along Donner Pass Road in Nevada and Placer Counties. The project is expected to begin during the summer of 2020.

The treated wastewater to be used for dust control is treated and disinfected pursuant to Order No. R5-2015-0068. The WWTF produces effluent that meets California Code

of Regulations, Title 22, section 60301.220, requirements. Recycled water will be used as needed for dust control along Donner Pass Road and will be managed to prevent runoff from application areas to reaching surface waters.

The Discharger submitted an *Engineering Report Amendment – Recycled Water for Road Dust Control – Resolution R5-2018-0085 (Amendment)*, dated 14 February 2020 to the Division of Drinking Water (DDW). Additional information was submitted on 21 May, 1 June, 18 June, and 29 June 2020. On 7 July 2020, DDW issued a letter that states the Amendment was conditionally accepted. As stated in the letter, the Amendment includes sufficient information to allow the Discharger to use disinfected tertiary recycled water for dust control for the duration of the Donner Pass Road improvement Project.

The Water Quality Control Plan for the Sacramento River and San Joaquin River Basins, Fourth Edition, revised October 2011 (hereafter Basin Plan), designates beneficial uses, establishes water quality objectives, contains implementation plans and policies for protecting waters of the basin, and incorporates by reference plans and policies adopted by the State Water Resources Control Board. Pursuant to §13263(a) of the California Water Code (CWC), waste discharge requirements must implement the Basin Plan.

FACILITY-SPECIFIC REQUIREMENTS

Please review the attached waiver documents and ensure that the discharge complies with the Conditions of Discharge contained in Attachment A. Donner Summit Public Utilities District is responsible for compliance with the waiver and must provide sufficient contractor oversight to ensure compliance and prompt reporting of any noncompliance.
