

CURRENT ACTIVITIES


Engineering

- DSPUD contract with Auerbach Engineering for public sewer design
- DSPUD lead agency for public sewer installation

Funding

- Public sewer funded by a property assessment
- Paid lump sum or paid on annual property tax
- DSPUD adopted a separate connection fee
